#### **New Business:**

### 114 South Street

Scot Kenworthy (Proponent), updated the MHC on the status of the proposed new 2-family house next to Grandfather's House.

#### Objectionable items:

- Needs to be marketed as a single family; no single driveway will be accepted.
- Proponent rejected moving the house site plan forward as investigated by MHC
- Proponent rejects the idea that parking anywhere other than the front of the house.
- Proponent does not want to make requested architectural changes as suggested by the MHC other than the addition of dormers on the front elevation.
- On 4/16/14, proponent will appear before the Conservation Commission.
- Proponent is adamant that his design is the design.

#### 23 Tucker Street

John Macavene (proponent) proposing to do a tear-down of the property and build six houses in its stead at previous meeting. No update or communication from proponent.

Interpretive sign location at base of reconstructed bridge. Sub-Committee met on 04/13/14. Circled around the Drive-In and Medford Bowl uses. Draft up text and images and send to MassDOT

# **Budget for FY 2015**

MHC to join Preservation Massachusetts,

Historic New England, National Council of Preservation Council. Budget \$10,700 in FY 2014 with approx. \$3k left. Myrtle Street area form was chosen as a good use of these funds, along with the Medford Police Station and Fire Station.

#### **Demolition Definition**

Sub-Committee (Ryan and Jim) met and reviewed. Informal survey of list serve. Several cities have a threshold of removing or covering 25% of exterior surface area to trigger demo. Working definition to be reviewed and presented to Medford Building Dept (Paul Mochi). The 25% number will require builders to have elevations or more documentation. J. Kossuth to check with Solicitor Mark Rumley to make sure there is no legal issues.

Several commission members handed in Form reviews. Request to get remaining forms from the Commission by the summer.
