**Proposed Revisions to Chapter 48, Article III of the
Revised Ordinances of the City of Medford:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MEDFORD AS FOLLOWS:

AMENDMENT ONE: Section 48-51(a) of the Revised Ordinances, City of Medford, Massachusetts, is hereby amended to read as follows:

Under the authority of M.G.L.A. c. 40C, § 3, the following historic districts, bounded respectively and which are on file in the City Clerk's Office and made a part of this Article by reference, are hereby established:

- (1) Hillside Avenue Historic District
- (2) Marm Simonds Historic District

AMENDMENT TWO: Section 48-51(a) of the Revised Ordinances, City of Medford, Massachusetts, as amended in Section 1, is hereby further amended to read as follows:

Under the authority of M.G.L.A. c. 40C, § 3, the following historic districts, bounded respectively and which are on file in the City Clerk's Office and made a part of this Article by reference, are hereby established:

- (1) Hillside Avenue Historic District
- (2) Marm Simonds Historic District
- (3) 16 Foster Court Historic District**
