# **August 14, 2023 Medford Historical Commission Minutes**

Meeting held via Zoom - Meeting called to order at 7:02 pm. Digital Meeting statement read by Ryan Howard at beginning of meeting.

<u>Members present:</u>, Ryan Hayward, Doug Carr, Jessica Farrell, Kit Nichols and Peter Miller. <u>Absent:</u> Jennifer Keenan and Edward Weist. Denis MacDougall also attended.

#### **421 High Street - Site Plan Review Comments:**

• The commission discussed the proposed project drawing set dated 05-08-2023 and compared the design to the earlier drawing set of 12-04-2019. The 05-08-2023 design was seen to be similar in scope and massing to not warrant further comments. Finding the current design to be acceptable, the commission decided to pass on review.

#### **Walkling Court - Form A Review for Project:**

• The commission reviewed the Form A executed by Claire Dempsey. Commissioners asked for clarification regarding possible National Registry eligibility for Walkling Court, and recommended that the existing housing complex be documented as part of the upcoming project PNF. Gabe Ciccarelli, Nathalie Janson, Jeffrey Driscoll of the Medford Housing Authority attended the meeting along with Margaret Donnelly-Moran, consultant from the Cambridge Housing Authority, made comments about their wish to not have the project delayed. R. Hayward stated that the documentation could be a parallel process and need not impeded the project's progress.
