Determinations of Preferably Preserved Status:

• <u>18 Wedgemere Road:</u> The demolition delay hearing for this property has been tabled pending owner's property decision.

Fire Department Safety Complex:

• P. Miller attended 6-21-2024 design meeting. Denis MacDougall to provide link to current drawings.

Walkling Court Senior Housing Development Proposal:

- R. Hayward to reach out to building department as follow up to determine if the following items have been provided for prior to permit approval:
 - NHPA Section 106 process.
 - Appropriate documentation prior to demolition.
 - Plan in place for architectural monitoring during demolition.

UU Church, 147 High Street, CPA Grant Process:

Joan Keane of Arlington, MA and Medford UU Church representative attended the
meeting and inquired about CPA funding grant for various preservation initiatives,
including shingle siding, doors, portico ceiling, etc. D. Carr and R. Hayward urged
that the UU Church to provide documentation of the proposed preservation work
including drawings, photos and lists to document the work for CPC review.

Cross Street Cemetery Update:

• Funding is in place for the headstone restoration project. Archaeological project awaiting bid proposals from candidate consultants.

Update on CPA Projects:

• Thomas Brooks Park: Archaeological cap project has been circulated to the city department heads. Public meeting with Peter Hedlund to be scheduled. Next phase items including tree work, crosswalks, etc. Regular DPW maintenance needed to clear brush and weeds from wall encroachment. R. Hayward and J. keenan to reach out to DPW.

Survey Projects Update:
